SUPPORTING INFORMATION:

Applicant, MUSC Holdings, LLC, was granted an Interim Use Permit (the "Permit") from the City on November 15, 2018 for the development of two surface parking lots to the immediate West of the soccer stadium being constructed on 400 Snelling Avenue North. The initial term of the Permit was for five years and will terminate November 15, 2023. Due to the Pandemic and ensuing economic downturn in the past five (5) years, the re-development of the surrounding property as approved in the 2016 Snelling-Midway Redevelopment Master Plan has been delayed. Applicant is requesting an extension of the Permit for another five (5) years, until November 15, 2028. The two surface parking lots will continue to be used in connection with the use of Allianz Field as provided in the original Permit.
