It is my understanding no permit was obtained and approved and no appeal was filed with the building officiation, which means the Fire Certificate of Occupancy was issued in error.

Sec. 40.06. - Suspension, revocation and denial. (a)Grounds for revocation. The fire code official may, in writing, issue a notice to the owner(s) and known interested parties of the city's suspension or revocation of a fire certificate of occupancy issued under the provisions of this code, or deny an application therefor: (1) Whenever the certificate was issued in error, or on the basis of incorrect information supplied.

I understand t there is a hearing today at 3:30pm to address this issue and you were wondering if needed to attend. With the late notice I have copied the Legislative Hearings email to request a layover of this item as Inspector Tessman will need to reissue the appropriate orders.
