I would like to provide additional information for your consideration.

This property has been damaged by fire. When I started to have it repaired, I had hard time to find right contractors. Everybody is busy and everything is slow. While my general building contractor was working on repairing fire damages, I was only able to have electric contractor and got his proposal much later on Feb. 28, 2023 (see the attachment). The repair really has been taking a long time than I anticipated.

The repair work has been almost done. Then someone broke in the property and stole the pipes for water, heat and even the water meter, and electric wires on last June 2023 (see the attached police report). This caused me taking additional long period of time taking care of another round of plumbing, heating and electrical work and dealing with insurance. These works are under progress.

Thanks for hearing me and I hope this information helps explaining why it is taking so long. I myself do not welcome the situation I am in.
