Mr. Savasten,

Realized I meant to include information about the forthcoming Vacant Building assessment in my letter and appealing that, and neglected to do so.

Right now it doesn't even have a date scheduled, Mr. Berger, as owner of record would be getting the assessment notice in the mail. **Make sure this is not paid, and then contact us (me) to appeal it.** There is no fee for appealing an assessment. Then you can speak with Ms. Moermond about prorating the fee for your time in the program depending on when the Code Compliance certificate is issued. As you can see, the cost went up significantly this year.
