Dear Property Representative:

An inspection was made of your building on January 4, 2024 in response to a referral. You are hereby notified that the following deficiency list must be corrected immediately. A reinspection will be made on or after January 18, 2024.

Failure to comply may result in a criminal citation or revocation of the Certificate of Occupancy. The Saint Paul Legislative Code requires that no building shall be occupied without a Certificate of Occupancy. The code also provides for the assessment of additional reinspection fees.

DEFICIENCY LIST

1. SUITE 101 - LOWER LEVEL NORTH SIDE - SPLC 34.23, MSFC 111.1 - This occupancy is condemned as unsafe or dangerous. This occupancy must not be used until re-inspected and approved by this office.
-This tenant space has been condemned as a result of unsafe and unapproved occupancy use. This unoccupied space was last approved as a (B) business occupancy. On 01/01/2024 the Saint Paul Police Department responded to a complaint and observed significant overcrowding, unsafe conditions, and evidence of discharged fireworks inside suite 101. The space cannot be occupied for any reason until inspected and approved by the Department of Safety and Inspections.
2. SUITE 101 - LOWER LEVEL NORTH SIDE - SPLC 40.06 - Uncertified portions of the building must not be occupied until inspected and approved by this office.
-Space is condemned due to unapproved and unsafe use.
