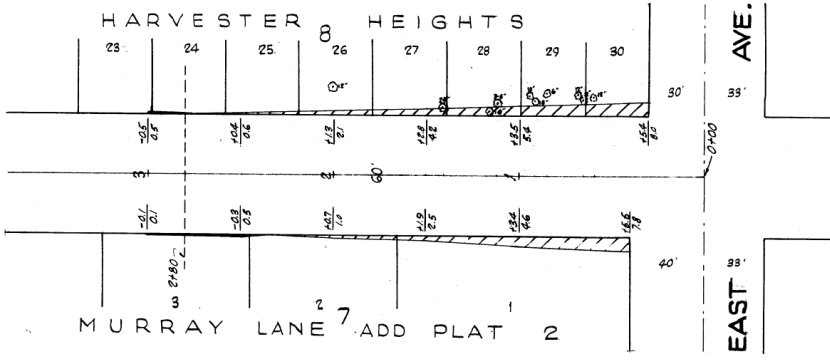
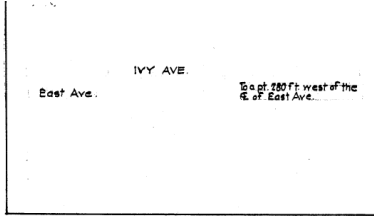

FINAL ORDER IN CONDEMNATION PROCEEDINGS

Council File No. 181533—By Frank D. Marzittelli—

In the matter of condemning and taking an easement in the land necessary for slopes, cuts and fills in the regrading of Ivy Ave. from East Ave. to a point 250 ft. west of the center line of East Ave. to the proposed change of grade, under Preliminary Order 180751, approved December 13, 1956, Intermediary Order 181152, approved January 22, 1957.

A public hearing having been had upon the above improvement upon due notice, and the Council having heard all persons, objections and recommendations relative thereto, and having fully considered the same; therefore, be it

Resolved, By the Council of the City of St. Paul that the precise nature, extent and kind of improvement to be made by the said City is condemning and taking an easement in the land necessary for slopes, cuts and fills in the regrading of Ivy Ave. from East Ave. to a point 250 ft. west of the center line of East Ave. to the proposed change of grade and the Council hereby orders said improvements to be made.

Resolved Further, That the following land, lands or easements therein be and the same are hereby ordered to be taken, appropriated and condemned for the purpose of making said improvements, viz.:

For slopes, cuts and fills in the regrading of Ivy Ave. from East Ave. to a point 250 ft. west of the center line of East Ave. to the proposed change of grade, to the extent shown on the plan on file in the office of the Commissioner of Public Works.

Resolved Further, That the Commissioner of Public Works be and is hereby instructed and directed to prepare plans and specifications for said improvement, and the proper city officials are hereby authorized and directed to proceed with the making of said improvement in accordance therewith.

Resolved Further, That the said assessment of benefits, be and the same is hereby in all respects ratified, and the same is hereby ordered to be submitted to the District Court for confirmation.
