1SPLC 105. - BOULEVARD PLANTING: Cut/trim or remove and properly dispose of any plantings in violation of Chapter 105. (Additional requirements in Chapter 45)

- 1) Plantings must be maintained in such a way that there is no overhang or encroachment onto the sidewalk, curb, or street area.
- 2) Plantings may not exceed thirty- six (36) inches in height.

PLEASE CUT, REMOVE, AND PROPERLY DISPOSE OF THE BOULEVARD PLANT GROWTH AND VEGETATION TO A HEIGHT OF UNDER 36 INCHES AND OVERHANGING ONTO THE PUBLIC SIDEWALK. THANK YOU. Comply before August 15, 2024

If you do not correct the nuisance or file an appeal before **August 15**, **2024**, the City will correct the nuisance and charge all cost, including boarding costs, against the property as a special assessement to be collected in the same way as property taxes. Charges: If the City corrects the nuisance, the charges will include the cost of correction, inspection, travel time, equipment, etc. The rate will be approximately \$260 per hour plus expenses for abatement.

APPEALS:You may appeal this order and obtain a hearing before the Legislative Hearing Officer by completing an appeal application before the deadline noted above or seven (7) days after the date mailed, whichever comes first. No appeals may be filed after that date. You may obtain an appeal application from the City Clerk's Office, Room 310 City Hall, 15 W. Kellogg Blvd., St. Paul, MN 55102. (651) 266-8585. You must submit a copy of this Order with your appeal application.

WARNING: If violations are not corrected by the compliance date, the city's costs will be assessed to the property taxes of the related property. If additional new violations are discovered within the next 12 months, additional charge may apply.
