

## RESOLUTION 11-04 Gordon Square Agreement

WHEREAS, the Saint Paul Parks and Recreation Commission ("Commission") is an appointed body established to advise the Mayor and City Council on long-range and city-wide matters related to Parks and Recreation; and

WHEREAS, Section 13.01.1 of the City Charter requires that the Commission review any diversion or disposal of park property and present a recommendation to the Saint Paul City Council; and

WHEREAS, the City of Saint Paul, Department of Parks and Recreation, owns city park land, known as Gordon Square (2270 Blake Avenue), a small triangular parcel abutting the residential property at 35 Langford Park in the Northwesterly part of the City (as shown on Attachment A); and

WHEREAS, Sara Billings LLC, owner of 35 Langford Park, is requesting to purchase Gordon Square for the purpose of owning the land upon which an encroaching garage is currently situated; and

WHEREAS, said purchase of Gordon Square would occur in conjunction with the vacation of right-of-way situated between 35 Langford Park and Gordon Square; and

WHEREAS, the Department of Parks and Recreation has determined that the park land may be disposed of for this purpose and recommends Commission support for the request; now, therefore

BE IT RESOLVED, that the Saint Paul Parks and Recreation Commission concurs with the request to dispose of city park land known as Gordon Square, located at 2270 Blake Avenue, as shown on Attachment A, through a Quit Claim Deed to Sara Billings LLC, and in accordance with City Charter Section 13.01.1 recommends approval by the Saint Paul City Council.


