NOTICE OF VIOLATION

Nader Nooryshokry 3N Enterprise 545 University Avenue West St. Paul, MN 55103

All licenses held by Nader Nooryshokry d/b/a 3N Enterprise for the premises located at 545 University Avenue RE:

West in Saint Paul

Dear Nader Nooryshokry:

The Department of Safety and Inspections (DSI) will recommend adverse action against all licenses held by Nader Nooryshokry d/b/a 3N Enterprise for the premises located at 545 University Avenue West in Saint Paul. The basis for the recommendation is as follows:

On November 23, 2010, an inspector from the Department of Safety and Inspections (DSI) came to your establishment for an inspection and cited you for the following license condition violations:

- There were 36 cars parked on the lot in violation of license condition #1 which states: 1) "No more than twenty-one (21) vehicles for sale are displayed on the lot, at any one time."
- The lot was so full that a customer would not have been able to pull into the lot in 2) violation of license condition #4 which states: "The interior maneuvering lane, illustrated on this plan, shall remain open an unobstructed so that the vehicle entering or exiting the property are proceeding forward. No backing into the street or from the street to this property is allowed."
- There were four (4) cars parked on University Avenue that appeared to be associated 3) with your business in violation of license condition #10 which states: "All "for sale" vehicles, associated with this business, must be parked on the lot. There shall be no parking on the street or any other public right-of-way."

You were given until December 30, 2010 to bring your licensed establishment into compliance with your license conditions. On December 27, 02010, DSI records show your requested an extension and was given until January 14, 2011.

3. If you dispute the facts outlined above, you may request a hearing before an Administrative Law Judge (ALJ). At that hearing both you and the City will appear and present witnesses, evidence and cross-examine each other's witnesses. After receipt of the ALJ's report (usually within 30 days), a public hearing will need to be scheduled. At that time, the City Council will decide whether to adopt, modify or reject the ALJ's report and recommendation. If this is your choice, please advise me no later than **Thursday**, **April 28**, **2011**, and I will take the necessary steps to schedule the administrative hearing.

If you have not contacted me or the Senior License Inspector by Thursday, April 28, 2011, I will assume that you are not contesting the imposition of the \$1,000.00 matrix penalty. In that case, the matter will be placed on the City Council Consent Agenda for approval of the recommended penalty.
