Description of Variance:

Noise Source: Northern Spark (Northern Lights.mn) is requesting a seound level variance for a one-night, all-night arts festival beginning at 7:00 PM on June 4, through 5:28AM on June 5, 2011 at various locations in the City of Saint Paul.

Locations:

Northern Spark Pre-Event Concert – electronic music out of speakers

Time: June 4, 2011 from 7:00 PM to 8:30 PM

Location: History Theater at 10th Street W. and Cedar Street

Applicant estimates sound levels will be less than 85 dBA at 50 feet from the source.

Movies Programming with audio from speakers

Time: June 4, 2011 at 8:55 PM to June 5, 2011 at 5:28 PM

Location: Saint Paul Central Library Courtyard – 76 Kellogg Blvd W.

Applicant estimates sound levels will be less than 80 dBA at 50 feet from the source.

American Composers' Forum – Collection of music to be output by speakers

Time: June 4, 2011 at 8:55 PM to June 5, 2011 at 5:28 AM

Location: Broadway Street between Prince Street and Kellogg Blvd E.

Applicant estimates sound levels will be less than 80 dBA at 50 feet from the source.

Schubert Club's 3 Horn Fanfare – Three (3) horns, played for five (5) minutes from the balcony on the north side of the Landmark building

<u>Time:</u> June 4, 2011 at 8:55 PM, 9:30 PM, 10:00 PM, 11:00 PM, June 5, 2011 at 12:00 AM, and 5:28 AM

Location: North side of Landmark Building/Hamm Plaza

Applicant estimates sound levels will be less than 80 dBA at 50 feet from the source.

Flint Hills and Ordway live puppet performers with amplified music accompaniment

Time: June 4, 2011 at 9:35 PM to 9:55 PM and 10:05 PM to 10:25 PM

Location: Landmark Plaza, 370 St Peter St

Applicant estimates sound levels will be less than 80 dBA at 50 feet from the source.

Opening Event – Eight (8) cars playing a musical composition on their horns

Time: June 4, 2011 8:55 PM to 9:03 PM

Location: Upper Landing Parking Lot - Shepard Rd

Applicant indicates that performance is limited to 8 minutes or less, cars will face away from residential.

Sewer Pipe Organ – Speakers installed beneath sewer grates
