PO repeatedly asked for extensions, and was ultimately denied, resulting in a Q3 and Q4 2024 tax assessment. WM agreed to remove charges as new hold was submitted. I assisted PO in establishing a new UDRF with no definitive end date.

She however claims that she also sent WM a Temporary Service Hold in December of 2023, another one in May 2024, a third one in July 2024 and resent her July one in October of 2024. Please check with WM on her Temp Holds, as she doesn't feel she should have to pay her bill for Q3 2024 (no bills were sent to her for the previous quarters). Also, she received a Q4 2024 bill which she also doesn't feel she should pay since she filed the numerous Temp Holds.

Jill, can you follow up with WM on her Temp Hold filings. If they have a record of them, she should also not be charged for Q4 2024. Thank you!
