Dear Property Representative:

Your building was inspected on April 21, 2011 for the renewal of your Fire Certificate of Occupancy. Approval for occupancy will be granted upon compliance with the following deficiency list. The items on the list must be corrected prior to the re-inspection date. A reinspection will be made on May 25, 2011 at 1:00 pm.

Failure to comply may result in a criminal citation or the revocation of the Fire Certificate of Occupancy. The Saint Paul Legislative Code requires that no building shall be occupied without a Fire Certificate of Occupancy. The code also provides for the assessment of additional reinspection fees.

YOU WILL BE RESPONSIBLE FOR NOTIFYING TENANTS IF ANY OF THE FOLLOWING LIST OF DEFICIENCIES ARE THEIR RESPONSIBILITY.

DEFICIENCY LIST

- 1. 2nd Floor Hallway MSFC 1010.5 Provide and maintain an approved emergency lighting system.-Repair non-working emergency light.
- 2. All Units MSFC1026.1 Provide and maintain an approved escape window from each sleeping room. The minimum size must be 5 square feet of glazed area with a minimum of 24 inches of openable height and 20 inches of openable width. With a finished sill height not more than 48 inches. This work may require permit(s). Call DSI at (651)-266-9090. Refer to the Escape Windows for Residential Occupanices handout for more information.-Building has 16 units, all studio and 1 bedroom units. All bedroom double-hung windows do not meet openable height requirement.

- 4 Units: Windows have an openable area of 21.75 inches high by 27 inches wide and a glazed area of 51 inches high by 27 inches wide, 9.6 square feet.
- 4 Units: Windows have an openable area of 21.75 inches high by 33 inches wide and a glazed area of 51 inches high by 33 inches wide, 11.7 square feet.
- 4 Units: Windows have an openable area of 17.5 inches high by 27 inches wide and a glazed area of 42 inches high by 27 inches wide, 7.9 square feet.
- 4 Units: Windows have an openable area of 17.5 inches high by 33 inches wide and a glazed area of 42 inches high by 33 inches wide, 9.6 square feet.
- 3. Electrical Room MSFC 510.1 Provide FIRE ALARM PANEL sign on door.
- 4. Laundry Room Ceiling MSFC 703 Repair and maintain the required fire resistive construction with approved materials and methods. This work may require a permit(s). Call DSI at (651) 266-9090.
- 5. Unit 11 Bathroom Tub SPLC 34.11, SBC 2902.1, SPLC 34.17, MPC 415.0220 Repair or replace and maintain the plumbing fixture to an operational condition.-Repair dripping faucet.
- 6. Unit 14 Bathroom Sink SPC 4715.0400 Provide approved plumbing materials for water, waste, and vent.
- 7. Unit 3 MSFC 703 Provide, repair or replace the fire rated door and assembly. The minimum rating must be: 20 minutes.-Repair and maintain the door closer.
- 8. Unit 7 MSFC 703 Provide, repair or replace the fire rated door and assembly. The minimum rating must be: 20 minutes.-Repair and maintain the door closer and latch.
- 9. Units 12, 15 SPLC 71.01 Provide identification numbers on unit door.
- 10. SPLC 34.08 (5), 34.31 (3) Repair, replace and maintain all exterior surfaces on fences, sheds, garages and other accessory structures free from holes and deterioration. Provide and maintain exterior unprotected surfaces painted or protected from the elements.-Repair damaged area of fence.

 Per legislative appeal, this work must be completed by September 1, 2011.
- 11. MSFC 907.20 as amended Provide required annual maintenance of the fire alarm system by a qualified person and provide written documentation to this office as proof of compliance.
