Please take notice that this matter has been set on the Public Hearing Agenda for the City Council meeting has been scheduled for **Wednesday**, **July 6**, **2011 at 5:30 p.m.**, in the City Council Chambers, Third Floor, Saint Paul City Hall and Ramsey County Courthouse.

Enclosed are copies of the resolution and supporting documents which will be presented to the City Council for their consideration. This is a matter pursuant to the fact that on February 15, 2011, the Minnesota Department of Revenue seized tobacco products in your establishment that had not been purchased by a licensed seller in violation of Minn. Stat. § 297F.13, subdivision 4. This matter has been placed on the public hearing agenda portion of the City Council meeting during which public discussion is allowed. Per Saint Paul Legislative Code § 310.05 (m) (2), the licensing office will recommend a \$500.00 matrix penalty.

As per a telephone conversation you had with my Legal Assistant on June 16, 2011, you are only able to contest the \$500.00 matrix penalty recommended by the Department of Safety and Inspections, not the seizure of the tobacco products, which can only be challenged with the Minnesota Department of Revenue within sixty (60) days of seizure.

If there is any information you would like City Council to review prior to the public hearing, I will need to receive it no later than Monday, June 27, 2011.
