Saint Paul Legislative Code, 62.102: For purposes of this section, a use will be presumed legally nonconforming if it can be demonstrated by clear and convincing evidence that prior to the effective date of this Ordinance (12-13-76) the use was established, converted, or enlarged pursuant to building permits issued by the City of St. Paul; or if it can be demonstrated by clear and convincing evidence that the particular use had been in existence continuously for twenty years prior to the effective date of this Ordinance. The burden of proof shall be on the applicant for a permit or certificate of occupancy as the case may be.

In 1957 the back garage was built. I lived in a house trailer beside that area at the time. I had a second house trailer that was in the area of the front garage until about 1959, at

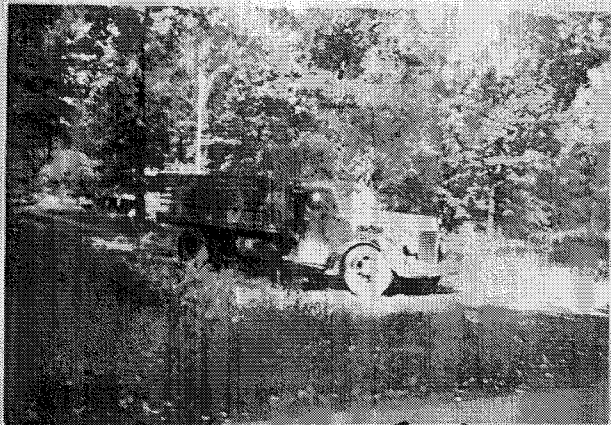


To Whom It May Concern

I have know Robert D. Jones since 1962 and have continued to be associated with him through these many years. The initial association with Bob started when I and 3 or 4 other individuals lived with and rented from him at the Totem Road location. I lived and rented there from October 1962 to September 1964.

During the time I lived at Bob's I always had more than one vehicle and/or trailer etc. In my case, I owned a car and a "pop up" camper. Several of us also jointly owned a retired Metro Transit bus that we had converted for use as a camper for hunting/fishing and for attending road racing events. This vehicle was parked at the Totem Road address when not in use.

Bob and all the men renting from him during the time I was there (October 1962 to September 1964) all owned multiple vehicle with the exception of one individual. These many vehicles were all parked at Bob's residence.
