A re-inspection was made on your building on June 17, 2011, in response to a referral. You are hereby notified that the following deficiencies must be corrected immediately.

Failure to comply may result in a criminal citation or the revocation of the Certificate of Occupancy. The Saint Paul Legislative Code requires that no building shall be occupied without a Certificate of Occupancy. The code also provides for the assessment of additional reinspection fees.

#### **DEFICIENCY LIST**

- 1. INTERIOR - UNIT 1 - SPLC 34.14 (2), 34.34 (5) - Provide an approved electrical service adequate to meet the buildings needs. This work may require a permit(s), call DSI at (651) 266-9090.-Failure to restore electric service has resulted in condemnation.
- 2. INTERIOR - UNIT 1 - SPLC 34.23, MSFC 110.1 - This occupancy is condemned as unfit for human habitation. This occupancy must not be used until re-inspected and approved by this office.-Failure to restore electric service has resulted in condemnation.
- 3. INTERIOR - UNIT 1 - SPLC 33.05 - Uncertified portions of the building must not be occupied until inspected and approved by this office.
