CORRECTION NOTICE

RE: **1270 CLEVELAND AVE S**

Dear Sir or Madam:

The City of Saint Paul, Department of Safety and Inspections has inspected the above referenced property on **October 04, 2010** and has determined that the following deficiencies exist in violation of the Saint Paul Legislative Code¹ (see footnote 1, below).

1. VEHICLES: All vehicles must be correctly licensed, operable, secure from unauthorized entry, and parked on an improved surface. Correct violations; store in a garage or remove.

RED VEHICLE PARKED ON LAWN NEAR ALLEY. THIS IS NOT AN APPROVED PARKING SURFACE. IMMEDIATELY CEASE PARKING IN THIS AREA.

2. VEHICLES: All vehicles must be correctly licensed, operable, secure from unauthorized entry, and parked on an improved surface. Correct violations; store in a garage or remove.

BUICK YELLOW 786-919 APPEARS INOPERABLE. DEMONSTRATE THIS VEHICLE IS OPERABLE.

BUICK GREEN 786-918 APPEARS INOPERABLE. DEMONSTRATE THIS VEHICLE IS OPERABLE.

3. COLLECTOR VEHICLES: Collector vehicles must be screened from public view.

BUICK YELLOW 786-919 not screened from public view. Remove or screen from public view in an approved manner.

BUICK GREEN 786-918 not screened from public view. Remove or screen from public view in an approved manner.

4. **APPROVED PARKING SURFACE.** The surface that the collector vehicles are parked on is not connected to the street/alley with an approved surface (driveway) and the parking surface itself has not been maintained.

CONTACT ZONING TO DETERMINE WHAT STEPS ARE REQUIRED TO ENSURE THAT THIS IS STILL AN APPROVED PARKING SURFACE. SUBMIT AN NEW SITE PLAN FOR APPROVAL IF REQUIRED.

5. **APPROVED PARKING SURFACE:** The surface that leads to the attached garage has not been maintained.

CONTACT ZONING TO DETERMINE WHAT STEPS ARE REQUIRED TO ENSURE THAT THIS IS STILL AN APPROVED PARKING SURFACE. SUBMIT AN NEW SITE PLAN FOR APPROVAL IF REQUIRED.

You are hereby notified to correct these deficiencies in accordance with the appropriate codes. The Enforcement Officer will reinspect these premises on or after

October 29, 2010,

by which date the violations noted must be corrected. **Failure to correct these deficiencies may result in the issuance of criminal charges²** and/or a civil lawsuit, and possible abatement/assessment by the City. All repairs and new installations must be made in accordance with the appropriate codes. Permits may be obtained by calling 651-266-8989.

You may file an appeal to this notice by contacting the City Clerk's Office at 651-266-8688. Any appeal must be made in writing within 10 days of this notice. (You must submit a copy of this Notice when you appeal, and pay a filing fee.)
