Remove improperly stored or accumulated refuse including: garbage, rubbish, discarded furniture appliances, vehicle parts, scrap wood and metal, recycling materials, household items, building materials or rubble, tires, brush, etc., from yard areas, INCLUDING: Tree debris, yard waste, tire, cardboard and loose and scattered debris rear and side yard.
Cut and remove tall grass, weeds and rank plant growth.
Remove and properly dispose of all animal feces from yard areas.

etc. The rate will be approximately \$260.00 per hour plus expenses for abatement.
