Kyle Lundgren, Assistant City Attorney representing the Department of Safety and Inspections (DSI) described the violation. He said there was no prior license history, and DSI recommended imposing a \$200 fine.

Amy Spong, Heritage Preservation Commission (HPC), added testimony letters to the record and distributed a staff report. She noted that it was an appeal of an HPC staff decision rather than a committee decision. She reviewed the findings in staff report and clarified that the HPC regulated fences but not plantings. She read from the Hill District Design Review Guidelines and said staff now believed staff did err in their decision to approve the application.

Councilmember Carter noted that he'd heard from a number of people, and the goals of both sides were not mutually exclusive. He said his intention was to ask for a 3 week layover to try to get the two sides together.

Appellant:

Shari Wilsey reviewed her communication with the HPC regarding the fence and said she felt they had erred. She said she did not oppose the garden but did oppose the fencing. She distributed photographs of churches without fences and said churches were intended to be open. She said if this was allowed it would open it up for everyone else on Summit Avenue to

Other testimony

Joann Lee (1055 Laurel Avenue), Pastor at House of Hope, read a statement about how the garden and its protecting fence supported their mission.

Mary Senkbeil (2184 Dahl Avenue) said she had applied for the fence permit and felt it was fundamentally unfair to accept the appeal and revoke the permit now. She read the description of the fence included in the permit application, and said the permit was issued for that fence specifically.

Councilmember Carter asked how much the fence cost. Ms. Senkbeil said it had cost a substantial sum but she would not disclose the amount unless the City reimbursed them in the event they were forced by the City to take it out.

At Councilmember Thune's request, Ms.Senkbeil clarified the amount of time between permit approval and the appeal. She said the fence was completed within the time specified on the permit, and the appeal was filed after the fence was completed.

Susan Rostkosky, Development Director at Neighborhood House (179 Robie Street) said without the fence, the Neighborhood House community wouldn't have access to fresh vegetables.

Tim Sheldon (1409 Englewood Avenue), church member, spoke about the importance of the garden to the community.

Paula Westmoreland (4105 Washburn Avenue N., Minneapolis) said the fence was carefully researched and designed for aesthetics and to be appropriate for the area.

Nadja Berneche, Program Director at Gardening Matters, spoke about the importance of a fence in a community garden.

Joe Beckman (768 Summit Avenue) reiterated the points about the fence description being included in the permit application, and the amount of time that passed before the appeal.

Scott Hayman (776 Summit Avenue) said he felt the fence was done tastefully and was a good compromise as is.

Linda Lane (1920 Eleanor Avenue), member House of Hope, spoke of the importance of a fence and of the garden's current location.

Councilmember Carter moved to close the public hearing. Yeas - 4 Nays - 0 (Bostrom not present for vote)

Councilmember Carter moved a 3 week lay over. He said it was not his intention to ask the church to move the garden but to come up with a different fence design, and that Ward 1 might have had funds to help pay for it.

Councilmember Thune said he agreed that the garden should not be moved. He said community gardening had begun to be more prevalent in the city and should be embraced. He encouraged Councilmember Carter to wait until the season was over to change the fence, and said the use of NIF funds was a good idea.

Councilmember Harris said he would like someone to address the timing issue. Councilmember Carter said because it was a staff decision there had been no formal public notice, and public notice was when the fence went up.

Councilmember Harris requested clarification from Deputy City Attorney Jerry Hendrickson; he questioned where the burden was if it was a staff error. He asked that Mr. Hendrickson respond specifically to the issue of the timeliness of the appeal as noted in a letter from Brian Alton (representing House of Hope) and to copy the Council.

Amy Spong, Heritage Preservation Commission (HPC), gave a staff report including a brief history and description of the rehabilitation steps and HPC decisions. She displayed photographs. She said in October the HPC denied installation of glass block on the store front level, but the decision on glass block on the upper floors was not clear at that time. The applicant was allowed to apply again for glass block on the upper levels and the HPC denied the application on June 9, and that decision was appealed.

At Councilmember Harris' request, Ms. Spong showed additional photographs and discussed the guidelines for modern buildings in the historic area.

Councilmember Thune noted that the red fire escapes on the building were an architectural design element, and glass block was used in a similar way on the the Cosmopolitan Building. Ms. Spong said the architect had talked about the exposed fire escape as an homage to the historic fire escapes in the district, but the Commission felt the glass block on the Cosmopolitan was used in a very different way, and was recessed and less visible. She said there was limited use of glass block in the district.

Appellant:

Dave Brooks (366 E. 6th Street), developer/owner of the parking ramp and 60,000 sq. ft. of office building. He said the parking ramp was condemned by the City for structural problems and Control Data had moved out of the offices and hazardous material. He said he had invested 2.85 million in the property, he reviewed his other development projects, and described credentials of architect and designer.

Ed Hauksford (114 N. 4th St, Bayport, MN), designer, displayed photographs of the building and said the HPC responded favorably to initial designs. He described the process and communications with the HPC, and said the process became lengthy and complicated and they lost a potential tenant. He said there were guidelines for historic buildings and new construction but not for non-contributing existing structures, and guidelines adopted for this project were those for new construction.

Councilmember Thune asked whether the vertical fins were original to the building. Mr. Hauksford said they thought the structure was originally just a parking ramp and the vertical fins were added to obscure the parking and make it look more like an office building.

Mr. Hauksford said they'd drawn on design keys on other buildings in the area; he showed photographs. He said glass block was a significant feature to the Cosmopolitan Building. He said they felt glass block would accentuate the entrance to the building, relate it to the streetscape, and provide visual interest.

In response to a question from Council President Lantry, Mr. Hauksford said back-lighting would be addressed when they got a tenant; he said the addition of public art would be determined by building tenants as well. Council President Lantry noted that the appeal dealt only with glass block on the upper floors. Mr. Hauksford said the glass block was to obscure the parking and seal off the abandoned fire escape from public use. Dan Gleason (1175 Highway 36), architect, said this presented a great opportunity to do something with a building that was difficult to deal with in this context, and an opportunity to take an old building and bend the rules a little bit to make it look marvelous. He said glass block would be a small element and not in front.

Councilmember Thune moved to close the public hearing. Yeas - 5 Nays - 0

Councilmember Thune said he hated to deviate from the HPC's decision because they were a smart and consistent group, and this was a tough design problem because it was an existing building. He said he respected the developer's experience with historic buildings and appreciated the design. He said he couldn't find an argument against use of glass block, and the appellant's arguments were sufficient to uphold the appeal. He moved to grant the appeal, and said he felt there was a strong enough rationale for going against the HPC's decision in this situation that the Council wouldn't be setting a precedent.

Councilmember Harris said he wholeheartedly supported that. He expressed appreciation for Mr. Brooks' work and Mr. Thune's motion.

Councilmember Bostrom said the renovated building would provide a good welcome into downtown St. Paul.

Yaya Diatta described the variance request and appeal. He displayed photographs.

Appellant:

Leslie McMurray, Executive Director of the District 5 Planning Council (506 Kenny Road) distributed and read a letter outlining their responses to the findings of the Board of Zoning Appeals (BZA). She asked that the Council reject the findings.

Chuck Repke (1365 Prosperity), Executive Director of the District 2 Community Council, read a letter stating that complying with the setback requirements in the zoning code should not be considered a "practical difficulty." He said the property owner wanted to build a deck for the use of both tenants and was using the "practical difficulty" provision of the code to get around the setback requirement intended to protect the neighbor. He expressed the concern about the precedent that would be set if the Council upheld the BZA decision.

Ed Davis (1169 Lane Place), District Council Land Use Committee, addressed the impact of the variance on the neighborhood. He referred to letters in packet, and stressed the need to protect the quality of housing.

Cheryl Peterson, District 5 resident and committee member, addressed the applicant's argument that the stairway was needed for safety. She said an covered, enclosed stairway was safer than an exterior one.

Applicant:

Property owner David Hartman (784 Cottage Avenue E.) said the property was being completely rehabbed because of a fire. He said tenants were screened, and he didn't want tenants who were going to destroy the property. He provided photos of other properties within a block with exterior decks or stairwells. He said he would like a second exit for safety.

Sean Sellers (1288 Galtier Street), contractor, said he discovered during the rehab that the interior stairway to the second level was not up to code, and he decided to add a code-compliant stairwell. He said the interior stairway was not on the Code Compliance list, but it was his responsibility as the contractor to make sure everything was up to code. He said when the variance was applied for, one of the first comments by someone at the District Council meeting was that they just didn't like decks. Mr. Sellers said information provided the on variance application demonstrated that they were consistent with the Comprehensive Plan of St. Paul. He said the owner just wanted to make a building that was safe and affordable.

Councilmember Bostrom moved to close the public hearing. Yeas - 5 Nays - 0

Councilmember Bostrom said he appreciated the work of the owner, but was hard pressed to see a purpose to the side deck and stairway other than to raise the rent. He moved to grant appeal.
