An inspection was made of your building on September 9, 2011 in response to a referral. You are hereby notified that the following deficiency list must be corrected immediately.

A re-inspection will be made on September 23, 2011 at 1:45 PM.

Failure to comply may result in a criminal citation or revocation of the Certificate of Occupancy. The Saint Paul Legislative Code requires that no building shall be occupied without a Certificate of Occupancy. The code also provides for the assessment of additional re-inspection fees.

DEFICIENCY LIST

- 1. Exterior Rear SPLC 34.09 (2), 34.32(2) Repair or replace the unsafe stairways, porch, decks or railings in an approved manner. This work will require a permit(s). Call DSI at (651) 266-9090. -Contact a licensed structural engineer to evaluate the damaged stairwell. Provide documentation by 9/23/2011 at 1:45 PM. Repair in an approved manner and obtain approval under permit.
- 2. Exterior Rear Stairwell SPLC 34.23, MSFC 110.1 The stairwell is condemned as unsafe or dangerous. This stairwell must not be used until re-inspected and approved by this office.
- 3. Exterior Rear Stairwell MSFC 605.1 Repair or replace damaged electrical fixtures. This work may require a permit(s). Call DSI at (651) 266-9090.-Repair damaged light fixture.
- 4. Exterior Rear Stairwell SPLC 34.09 (2), 34.32(2) Repair or replace the damaged guardrail in an approved manner. This work may require a permit(s). Call DSI at (651) 266-9090.
