NOTICE OF INTENT TO REVOKE LICENSE

Osman Sed Elmi 2773 Asbury Street North Roseville, MN 55113

Taxicab Driver license held by Osman Sed Elmi for the City of Saint Paul

Dear Mr. Elmi:

The Department of Safety and Inspections will recommend revocation of the Taxicab Driver license held by Osman Sed Elmi for the City of Saint Paul. The basis for the recommendation is based on the following information:

According to Minnesota Department of Vehicle Services (DVS) records, your Minnesota Driver's license was revoked for ninety (90) days on May 21, 2011 for "Alcohol Concentration .08 or More" in violation of Minn. Stat. § 169A.20, Subd. 1. You applied for renewal of your Taxicab Driver's license with the Department of Safety and Inspections on September 1, 2011.

This is a violation of Saint Paul Legislative Code § 376.16 (e) (5) (b): "No prior license revocation within one year immediately preceding application as defined in Minn. Stat. § 169A.03, subd 21."

If you are contesting the revocation of your Taxicab Driver license, you have two options on how to proceed:

- 1. If you wish to admit the facts but you <u>contest</u> the penalty, you may have a public hearing before the Saint Paul City Council. You will need to send me a letter with a statement admitting to the facts and requesting a public hearing. I will need to receive your letter by **Monday, September 26, 2011.** The matter will then be scheduled before the City Council for a public hearing to determine whether to revoke your license. You will have an opportunity to appear before the Council and make a statement on your own behalf.
- 2. If you dispute the facts outlined above, or wish to present evidence that the conviction is not related to your license as a taxicab driver, or that you have been rehabilitated pursuant to Minn. Stat. §364.01 et seq, you may request a hearing before an Administrative Law Judge (ALJ). You will need to send me a letter disputing the facts and requesting an administrative hearing by Monday, September 26, 2011. At that hearing both you and the City will appear and present witnesses, evidence and cross-examine each other's witnesses. After receipt of the ALJ's report (usually within 30 days), a public hearing will need to be scheduled. At that time, the City Council will decide whether to adopt, modify or reject the ALJ's report and recommendation.

If you have not contacted me by Monday, September 26, 2011, I will assume that you do not contest the revocation of your license. In that case, the matter will be placed on the City Council Consent Agenda for approval of the recommended penalty.
