NOTICE OF INTENT TO SUSPEND LICENSES

RE: All licenses held by Shamrock Market, LLC d/b/a Shamrock Market for the premises located at 279 McKnight Road South in Saint Paul
License ID #20090002089

Dear Ibrahim Mohamoud:

The Department of Safety and Inspections (DSI) has recommended suspension of all licenses held by Shamrock Market, LLC d/b/a Shamrock Market for the premises located at 279 McKnight Road South in Saint Paul. The basis for the recommendation is as follows:

According to Department of Safety and Inspections (DSI) records, an inspector has been out to your establishment twice to hand-deliver delinquent license notices. These notices show your Cigarette/Tobacco and Retail Food (B) Grocery 101-1000 sq. ft. licenses expired as of May 27, 2011. You currently owe \$847.00 in delinquent license and late fees.

You were also required to complete the questionnaire at the bottom of the RENEWAL INVOICE and submit a completed Certificate of Compliance Minnesota Workers' Compensation Law form. As of today's date, neither the license and late fees nor the requested information has been received.

In addition to the suspension of your licenses, pursuant to Saint Paul Legislative Code §310.05 (m) (2), the licensing office will also recommend a \$500.00 matrix penalty for failure to submit the required information in order to maintain your license.

At this time, you have three options on how to proceed:

1. You can pay the delinquent license and late fees and submit the requested information. If this is your choice, you should send the payment and information directly to the Department of Safety and Inspections, at 375 Jackson Street, Ste. 220, St. Paul, Minnesota 55101-1806 no later than **Monday, October 17, 2011**. Information should be directed to the attention of Christine Rozek. A self-addressed envelope is enclosed for your convenience. Payment of the delinquent license and late fees and submission of the requested information will be considered to be a waiver of the hearing to which you are entitled.

2. If you wish to admit the facts but contest the penalty, you may have a public hearing before the Saint Paul City Council, you will need to send me a letter with a statement admitting the facts and requesting a public hearing. We will need to receive your letter by **Monday, October 17, 2011**. The matter will then be scheduled before the City Council for a public hearing to determine whether to suspend your licenses and impose the \$500.00 matrix penalty. You will have an opportunity to appear before the Council and make a statement on your own behalf.
3. If you no longer wish to do business in the City of Saint Paul, you will need to send a written statement to that effect to the Department of Safety and Inspections, at 375 Jackson Street, Ste. 220, St. Paul, Minnesota 55101-1806 no later than **Monday, October 17, 2011**. Information should be directed to the attention of Christine Rozek.

If you have not contacted me by Monday, October 17, 2011, I will assume that you do not contest the suspension of your licenses and imposition of the \$500.00 matrix penalty. In that case, the matter will be placed on the City Council Consent Agenda for approval of the recommended penalty.
