Your building was inspected on September 28, 2011 for the renewal of your Fire Certificate of Occupancy. Approval for occupancy will be granted upon compliance with the following deficiency list. The items on the list must be corrected prior to the re-inspection date.

A re-inspection will be made on October 31, 2011 at 10:15 am.

Failure to comply may result in a criminal citation or the revocation of the Fire Certificate of Occupancy. The Saint Paul Legislative Code requires that no building shall be occupied without a Fire Certificate of Occupancy. The code also provides for the assessment of additional re-inspection fees.

YOU WILL BE RESPONSIBLE FOR NOTIFYING TENANTS IF ANY OF THE FOLLOWING LIST OF DEFICIENCIES ARE THEIR RESPONSIBILITY.

DEFICIENCY LIST

- 1. EXTERIOR GARAGE SPLC 34.08 (5), 34.31 (3) Repair, replace and maintain all exterior surfaces on fences, sheds, garages and other accessory structures free from holes and deterioration. Provide and maintain exterior unprotected surfaces painted or protected from the elements.-Scrape and paint garage in a professional manner.
- 2. EXTERIOR SPLC 71.01 Provide address numbers on building per attached HN-1 handout.Provide rear address numbers that are clearly visible from the alley.
- 3. EXTERIOR SPLC 34.09 (3), 34.32 (3) Provide or repair and maintain the window screens.
- 4. EXTERIOR SPLC 34.09 (3), 34.32 (3) Repair and maintain the window locks.

- 5. EXTERIOR SPLC 34.10 (6), 34.33 (5) Exterminate and control insects, rodents or other pests. Provide documentation of extermination.-Remove wasp nest from eaves on north side of house, and birds nest under soffit on north side of house, and properly seal any access holes.
- 6. INTERIOR BASEMENT SPLC 34.10 (1) Abate and maintain the basement reasonably free from dampness and free of mold and mildew.
- 7. INTERIOR MSFC 1011.2 Remove the materials that cause an exit obstruction. Maintain a clear and unobstructed exitway.-Remove furniture from hallway outside bedrooms.
- 8. INTERIOR MSFC1026.1 Provide and maintain an approved escape window from each sleeping room. The minimum size must be 5 square feet of glazed area with a minimum of 24 inches of openable height and 20 inches of openable width. With a finished sill height not more than 48 inches. This work may require permit(s). Call DSI at (651)- 266-9090. Refer to the Escape Windows for Residential Occupanices handout for more information.-Egress windows in upstairs bedroom are awning type, 22.5 inches openable height x 45 inches openable width. The scissor hardware is in the center of the window.
- 9. SPLC 34.11 (6), 34.34 (3) Provide service of heating facility by a licensed contractor which must include a carbon monoxide test. Submit a completed copy of the Saint Paul Fire Marshal's Existing Fuel Burning Equipment Safety Test Report to this office.
- 10. SPLC 34.12 (2), 34.35 (1) Repair and maintain all required and supplied equipment in an operative and safe condition.-Reconnect downspout on east side of house. Kitchen windows do not open. Make all openable windows fully openable.
