Dear Jackie

I have incorporated the language you used in your e-mail with some changes, if this makes our understanding easier.

- 1) If the existing fencing, located at 786 S. Smith Ave., St. Paul, MN, is damaged in any way, MCMSI will replace it in a timely manner and be responsible for any and all labor/material costs. Materials to be similar to what is presently installed or an acceptable substitute agreed to by Ms. Sullivan and replacement installation to be performed as soon as grade is brought to permanent condition. All work to be done by MCMSI contractors or its own carpenters.
- 2) If damage of fencing or instability of same occurs during the construction process, MCMSI will supply temporary stable fencing that Jackie Sullivan's pet dogs (a Golden Retriever and a mixed breed of similar size) cannot jump over or go under/around/through at any time, and will still allow access for home owner in and out of yard as it is now. Said temporary fencing will be in place immediately upon any damage/instability occurring.
- 3) If you feel uncomfortable in regards to water usage or electrical usage, we will not put you in that position. We want this building process to be painless for you and your pets. We can bring water in and have a generator on site until our temporary power is installed.
