#### NARRATIVE

I, J.DOVERSPIKE Squad 148, was dispatched to 2516 7TH Street West, Raz Restaurant, for a fight between ten to fifteen people. On the way there, dispatch updated the call saying medics were enroute to the call.

When I arrived there was a male, later ID as JEMAL E OMER (DOB 2/23/74, 1901 Pierce St. #108 Sioux City, IA 51104), on the ground. There were several people around OMER but no one said they knew who he was. There was a male, MELES SOLOMON ESHETE (DOB 2/2/92, 1354 Maynard Drive E. #243 Saint Paul, MN 55116, C# 651-447-9886), who said his first name of JEMAL. ESHETE said OMER had been staying with him for one week and was going to leave for HOUSTON. OMER was living with him, ESHETE, because of his mother who met OMER one day and asked to live with them.

No one at Raz Restaurant saw or could describe the suspect who assaulted OMER. The people around said he was either hit with a bottle or punched in the face and then hit his head on the ground when he fell.

OMER was unresponsive on scene. Medics (Rig #66, Run #28445) transported OMER to Regions Hospital. I went to Regions and spoke to the doctors looking at OMER. The doctors said he was unresponsive and didn't appear to have any feeling below the waist. They were going to run some tests and place him in ICU.
