## NOTICE OF VIOLATION

Zinash Amde RAS Restaurant & Lounge 2516-7<sup>th</sup> Street West St. Paul, MN 55116

RE:

All licenses held by RAS Ethiopian Bar and Restaurant, LLC d/b/a RAS Restaurant & Lounge for the premises located at 2516-7<sup>th</sup> Street West in Saint Paul.

License ID #: 20100000062

Dear Mr. Amde:

The Department of Safety and Inspections (DSI) has recommended adverse action against all licenses held by RAS Ethiopian Bar and Restaurant, LLC d/b/a RAS Restaurant & Lounge for the premises located at 2516-7<sup>th</sup> Street West in Saint Paul. The basis for the recommendation is as follows:

On October 23, 2011, at approximately 2:15 a.m., Saint Paul Police were sent to your establishment regarding a fight between ten (10) to fifteen (15) people (CN #11-222-980). When the officer arrived, the suspect was gone and no one in your establishment could describe the suspect. The officer then requested a copy of videotape during the time of the incident. You told the officer that the only person with access to the office to make a copy was your wife and she would not be able to come until after 3:00 p.m. that afternoon.

This is a violation of license condition #3 which states: "... Tapes/recordings must be maintained for a minimum of thirty (30) days, and there shall be an employee on-staff at all times with the ability to make them immediately available to the SPPD and/or the Department of Safety and Inspections (DSI) upon request."

Therefore, per Saint Paul Legislative Code § 310.05(m) (2), licensing department will recommend a \$500.00 matrix penalty.

At this time, you have three options on how to proceed:

If you wish to <u>admit</u> to the violation you can pay the \$500.00 matrix penalty. You can send the payment to the Department of Safety and Inspections (DSI) located at 375 Jackson Street, Ste. 220, St. Paul, Minnesota 55101-1806 no later than **Monday**, **November 28**, **2011**. Information should be directed to the attention of Christine Rozek. A self-addressed envelope is enclosed for your convenience. Payment of the \$500.00 matrix penalty will be considered a waiver of the hearing to which you are entitled.

- 2. If you wish to admit the facts but you contest the \$500.00 matrix penalty, you may have a public hearing before the Saint Paul City Council. You will need to send me a letter with a statement admitting to the facts and requesting a public hearing. I will need to receive your letter no later than **Monday**, **November 28**, **2011**. The matter will then be scheduled before the City Council for a public hearing to determine whether to impose the \$500.00 matrix penalty. You will have an opportunity to appear before the Council and make a statement on your own behalf.
- 3. If you <u>dispute the facts</u> outlined above, you may request a hearing before an Administrative Law Judge (ALJ). You will need to send me a letter disputing the facts and requesting an administrative hearing no later than **Monday, November 28, 2011**. At that hearing both you and the City will appear and present witnesses, evidence and cross-examine each other's witnesses. After receipt of the ALJ's report (usually within 30 days), a public hearing will need to be scheduled. At that time, the City Council will decide whether to adopt, modify or reject the ALJ's report and recommendation.

If you have not contacted me by Monday, November 28, 2011, I will assume that you are not contesting the imposition of the \$500.00 matrix penalty. In that case, the matter will be placed on the City Council Consent Agenda for approval of the recommended penalty.
