Cut and remove tall grass, weeds and rank plant growth.
Remove and properly dispose of all animal feces from yard areas.

If you do not correct the nuisance or file an appeal before August 11, 2011 , the City will correct the nuisance and charge all costs, including boarding costs, against the property as a special assessment to be collected in the same way as property taxes. <u>Charges:</u> If the City corrects the nuisance, the charges will include the cost of correction, inspection, travel time, equipment, etc. The rate will be approximately \$260.00 per hour plus expenses for abatement.

*WARNING Code inspection and enforcement trips cost the taxpayers money.
