Dear Property Representative:

An inspection was made of your building on November 21, 2011 in response to a referral. You are hereby notified that the following deficiency list must be corrected immediately. **A re-inspection will be made on December 19, 2011 at 1:00PM.**

Failure to comply may result in a criminal citation or revocation of the Certificate of Occupancy. The Saint Paul Legislative Code requires that no building shall be occupied without a Certificate of Occupancy. The code also provides for the assessment of additional re-inspection fees.

DEFICIENCY LIST

- 1. BASEMENT FURNACE ROOM MSFC 703 Repair and maintain the required fire resistive construction with approved materials and methods. This work may require a permit(s). Call DSI at (651) 266-9090.-For Daycare purposes, furnace rooms must be secured from children. Replace the wall around the furnace in the laundry room or provide a door to the laundry room with a passage lock on the door handle. Furnace access through the basement bathroom must also be secured in a similar manner.
- 2. DECK STAIRWAYS APPROVED GUARDRAIL SPLC 34.09 (2) 34.32 (2) Provide an approved guardrail with intermediate balustrade or rails 4 inches or less apart. This work may require a permit(s). Call DSI at (651) 266-9090.-Provide approved balustrades for both stairways off of the backyard deck.
- 3. GARAGE DOOR INSTALL SELF CLOSER MSFC 703 The fire door must not be obstructed or impaired from its proper operation at any time.-The door that separates the garage and the dining area must have a self closer installed on the door.
- 4. NORTHEAST BEDROOM EGRESS WINDOWS The main floor NE bedroom's northside and eastside windows both have operable dimensions of 20 inches high by 24 inches wide.

- 5. NORTHEAST BEDROOM, SOUTHEAST BEDROOM, AND OVER GARAGE BEDROOM NORTHSIDE EGRESS WINDOW MSFC1026.1 Provide and maintain an approved escape window from each sleeping room. The minimum size must be 5 square feet of glazed area with a minimum of 24 inches of operable height and 20 inches of operable width. With a finished sill height not more than 48 inches. This work may require permit(s). Call DSI at (651) 266-9090. Refer to the Escape Windows for Residential Occupancies handout for more information.-All sleeping rooms have the same size windows with operable dimensions of 20 inches high by 24 inches wide.
- 6. OVER GARAGE BEDROOM CO DETECTOR MN State Statute 299F.50 Immediately provide and maintain an approved Carbon Monoxide Alarm in a location within ten (10) feet of each sleeping area. Installation shall be in accordance with manufacturer's instructions.-Provide a new battery for the over garage bedroom's CO detector.
- 7. OVER GARAGE BEDROOM EGRESS WINDOWS The over garage bedroom north side window's operable dimensions are 20 inches high by 24 inches wide.
- 8. SOUTHEAST BEDROOM EGRESS WINDOWS The main floor SE bedrooms east window and south window both have operable dimensions of 20 inches high by 24 inches wide.
