RE-INSPECTION FIRE CERTIFICATE OF OCCUPANCY WITH DEFICIENCIES 54 CHATSWORTH ST S

Dear Property Representative:

Your building was re-inspected for the Fire Certificate of Occupancy on November 21, 2011. Approval for occupancy will be granted upon compliance with the following deficiency list. The items on the list must be corrected immediately. A reinspection will be made on January 3, 2012 at 10:30 AM.

Failure to comply may result in a criminal citation or the revocation of the Fire Certificate of Occupancy. The Saint Paul Legislative Code requires that no building be occupied without a Fire Certificate of Occupancy. The code also provides for the assessment of additional reinspection fees.

DEFICIENCY LIST

1. Double hung windows - MSFC1026.1 - Provide and maintain an approved escape window from each sleeping room. The minimum size must be 5 square feet of glazed area with a minimum of 24 inches of openable height and 20 inches of openable width. With a finished sill height not more than 48 inches. This work may require permit(s). Call DSI at (651)- 266-9090. Refer to the Escape Windows for Residential Occupancies handout for more information.-

Unit 1

23 h x 26.75 w Glazed 8.8 sq ft

Unit 3

21.75 h x 28.75 w Glazed 10.5 sq ft

Unit 4

21 h x 26.75 w Glazed 9.4 sq ft

- 2. Throughout Including gas range in units 1 and 3 NEC 440.13 For cord-connected equipment such as room air conditioners, household refrigerators and freezers, drinking water coolers, and beverage dispensers, a separable connector or an attachment plug and receptable shall be permitted to serve as the disconnecting means. The appliance must plug directly into a permanent outlet.
- 3. Throughout SPLC 34.09 (3), 34.32 (3) Provide or repair and maintain the window screen.
- 4. Throughout MN Stat. 299F.362 Immediately provide and maintain a smoke detector located outside each sleeping area.-Properly maintain hard wired smoke detectors.

- 5. Unit 2 SPLC 34.19 Provide access to the inspector to all areas of the building.
- 6. Unit 3 MN Stat. 299F.362 Immediately provide and maintain a smoke detector located outside each sleeping area.
- 7. Unit 3 behind gas range MSFC 605.6 Provide electrical cover plates to all outlets, switches and junction boxes where missing.
- 8. Unit 4 Bathroom SPLC 34.10 (7), 34.33 (6) Repair and maintain the ceiling in an approved manner.-Scrape and remove chipped and peeling paint. Repaint in a professional manner.
- 9. SPLC 34.11 (6), 34.34 (3) Provide service of heating facility by a licensed contractor which must include a carbon monoxide test. Submit a completed copy of the Saint Paul Fire Marshal's Existing Fuel Burning Equipment Safety Test Report to this office.
- 10. SPLC 39.02(c) Complete and sign the provided smoke detector affidavit and return it to this office.
- 11. MSFC MSFC 1003.3.1.8 The maximum number of locks on unit doors is two. Remove all locks in excess of two.
- 12. MSFC 506.1 Provide a key in the keybox for the fire alarm panel. Call the Fire Department communication center at (651) 224-7371 to make arrangements to have the keybox opened when you have the correct keys on site.
