This is an uncontested matter concerning the fact that during a third (3<sup>rd</sup>) re-inspection on December 6, 2011, the DSI Inspector cited you with two (2) Critical-Minor Environmental Health Code violations that had not been corrected. The inspector returned on January 31, 2012 and found that one of the violations still had not been corrected.

Per Saint Paul Legislative Code § 310.05 (m) (9), the licensing office will recommend suspension of all licenses until that violation is corrected and the \$450.00 matrix penalty is paid.
