In response to a question by Councilmember Brendmoen, Ms. Schwarz described the orientation of the live music on the plaza. She said it was at the east end facing west, with the band inside a tent.

They said they had lived there for over a year and had running water. Ms. Tosure spoke about how the order to vacate had disrupted her child's schooling. Mr. Bailey said he'd done the work necessary to have running water in their apartment and hadn't known about the permit requirement. He said Mr. Goldman had removed items from the house and arranged for his trash hauler to pick them up but the City did the work before the private hauler came. He reiterated that they had been doing what they could and said Mr. Goldman was in the process of getting a loan to complete work on the house.

Property owner David Goldman said the inspector seemed to have an attitude that he (Mr. Goldman) belonged in a nursing home. He said he had an aide come in occasionally but was able to do everything himself. He said he'd lived in the house for almost 30 years, wanted to stay in the neighborhood, and didn't have anywhere else to go. He said he was looking into sources of assistance for fixing the house, and needed more time. He said he didn't have the money for the vacant property process. He said the house was almost cleaned up. He said he had contacted the History Center because his home was on the Federal Register. He said no one had notified him the City was coming to pick up the trash. Council President Lantry said that was a separate issue and would come before the Council later.

Councilmember Thune moved to close the public hearing. Yeas - 7 Nays - 0

Ms. Moermond said there had been a summary abatement for a substantial amount of material in the back yard, and Parks had performed the clean-up.
