> Dear Mr Tolbert

> I am writing to you in relation to real estate
> administration fee that I was assessed, upon completion of
> of the Davern-Jefferson Phase II Residential Street Vitality
> Project, that was completed last November.
> The issue unfolded as such: Once the breadth of this
> street/sewer/water pipe issue became clear, my task was
> obviously how to approach paying for it. After lengthy
> conversations with various city departments, which included
> Lori Lemke, in the Sewer Department, and Lisa Falk-Thompson
> in Construction, I deemed to pay for the project as the
> various pieces of it came due, and not to finance it. One
> of my issues against having the amount assessed, was the
> administration fees added on to the cost, which I see as
> front end interest. In the application for Sewer
> Assessment, they mention a \$60.00 administration fee, this
> is clear in the paperwork. I did not sign this document,
> nor submit it. This I initially discussed with Lori Lemke,
> in which I was told that the sewer project would be
> completed and billed in two parts. The sewer main to the
> property line and the house hook-up to the street or
> property line, to account for this delineation of
> billing.
> I was told that I would be billed for the project upon
> completion, and that the construction firm would bill me
> separately for final part of this project. The house part
> of it had been completed and paid for on 7/5/2012 as noted
> below, the sewer main to my property line being the final
> piece of the project, before the road repaving. I expected
> this late in 2011, as they finished in October. Later it
> was said that the billing would be done in Spring of 2012.
> My payments have been as such:

> Capra Construction \$3075.00 on 7/5/2011
> homeowner end of water pipe and sewer project
>
> City of St Paul \$2092.80 on 11/2/2011
> road paving and street lights
>
> I have been waiting for the statement for last piece of this
> project. It was done on time and was badly needed. I
> have no qualms with the project, the contractors or the City
> in any other aspect of this reconstruction.
> I was extremely dismayed, and angry when I received the
> notification of the Ratification of Assessment on March 1.
> Included in the total for this Assessment of which I
> submitted no request for, I was billed a \$118.72 Real Estate
> Administration Fee. I called Lori Lemke, the same day to
> question this. I was under the understanding that I was to
> be billed by the construction firm, and that this was not to
> go to the city for processing. She was of a similar
> understanding. It appears that the City of St. Paul wants
> \$118.72 to send me a bill for details they never gave me, on
> paperwork that I never signed. The Request for Sanitary
> Service Repair, that I submitted, and signed on 4/15/2011,
> made no mention of an assessment fee on the price quoted.
> It was broken down as a connection fee and \$ per foot.
> I question if the actions of the City of St. Paul are legal,
> not to mention ethical. I will be out of town for the
> hearing on 3/21/2012, in which this matter will be open for
> discussion. I would greatly appreciate any help that you
> could give me in this matter. This is very
> disconcerting. Thank you very much for your time. Please
> contact me as needed.
