NARRATIVE

On 01/18/2012, at 2147 hours Squad #361 (L. Ferraro) was dispatched to 667 E 5th St on an alarm. Dispatch informed me the alarm covered the kitchen and dining room motion.

When I arrived, I observed the north side kitchen window was broken out. I also observed a wood board laying on the ground, near the broken kitchen window.

Assisting Squads and myself set up on the perimeter of the house. Squad #615 (R. Vetsch) and his K-9 partner arrived on scene. Squad #615 and his K-9 partner searched the interior of the house with negative results. No one was found inside the house.

The key holder also arrived on scene after we cleared the interior of the house. I spoke with the key holder who verbally identified himself as OKNER, THOMAS LUKE (dob 03/14/1949; 12 Sunfish Lane, Sunfish Lake 55118; (h) 651-457-5600).

OKNER told me the following: The homeowner NOTEBAART, JAMES CHARLES (dob 01/18/1945; (h) 651-776-7988) is currently out of town. NOTEBAART's home was just recently broken into on 01/12/2012 (PCN 12-008-
