RE: Re-Inspection Fire C of O 957 3rd ST E

- 1. Basement Water Heaters for both units have been in basement since we purchased and renovated home in 2008—see attached C of O from Steve Zaccard Fire Marshal dated November 24, 2008. These have not been an issue and request that we can leave them both where they are installed. We could lock both residents out of basement if you prefer?
- 2. Egress Window in lower unit (double hung) south bedroom is 14.5w by 29.5h openable and 13.5w x 65h glazed. Request variance from openable width by 5.5 inches but we are 5.5 inches higher than required height. Please note we have two windows that are identical. Code requires 44 sq inches and our window is 44 sq inches. We believe we meet the glazed area requirement.

Your building was re-inspected for the Fire Certificate of Occupancy on March 9, 2012. Approval for occupancy will be granted upon compliance with the following deficiency list. The items on the list must be corrected immediately.

A re-inspection will be made on April 11, 2012 at 1:30pm.

Failure to comply may result in a criminal citation or the revocation of the Fire Certificate of Occupancy. The Saint Paul Legislative Code requires that no building be occupied without a Fire Certificate of Occupancy. The code also provides for the assessment of additional re-inspection fees.

DEFICIENCY LIST

1. Basement - Water Heater - SPLC 34.11 (6), MSPC 4715.1800 (subp 5), MSPC 4715.2240 - Every space heating, cooking and water heating device located in a structure shall be properly installed, connected, maintained and capable of performing the function for which it was designed in accordance with the provisions of the plumbing and mechanical codes. Every water heater installation shall be readily accessible for inspection, repair, or replacement.-Basement is only accessible by the main floor tenant. Water heaters for both the main floor and upper floor are located in the basement. Upper floor tenant doesn't have access to their water heater. Relocate the upper floor unit water heater or provide upper floor tenant independent access to the basement. This work may require a permit(s). Contact DSI at 651-266-8989.

2. Egress Window - MSFC1026.1 - Provide and maintain an approved escape window from each sleeping room. The minimum size must be 5 square feet of glazed area with a minimum of 24 inches of openable height and 20 inches of openable width. With a finished sill height not more than 48 inches. This work may require permit(s). Call DSI at (651) - 266-9090. Refer to the Escape Windows for Residential Occupancies handout for more information.

Lower Unit South Bedroom (Double-hung)

14.5w x 29.5h - Openable 13.5w x 65h - Glazed

- 3. Upper Unit Space Heater MSFC 105.1.1 Permits are required for the new installation of a space heater.-Obtain the required permit for the space heater installation and contact mechanical inspector for final inspection.
- 4. SPLC 34.11 (6), 34.34 (3) Provide service of heating facility by a licensed contractor which must include a carbon monoxide test. Submit a completed copy of the Saint Paul Fire Marshal's Existing Fuel Burning Equipment Safety Test Report to this office. Provide an Existing Fuel Burning Equipment Safety Test Report on the gas space heater located in the upper floor unit.

You have the right to appeal these orders to the Legislative Hearing Officer.
