NARRATIVE

On Tuesday, January 24, 2012, I, Sqd. 744 (Whisler) received this case. I read and reviewed all associated documents and reports available to me at the time. I initiated a telephone conversation with the complainant/victim in this case: LORRAINE LUTGEN.

LUTGEN told me the house has an alarm system, unfortunately it wasn't armed over the time frame of the burglary. LUTGEN was able to narrow down the time frame to an unknown time on Wednesday, January 18th to approximately 5PM on Monday, January 23rd. LUTGEN told me the value of the jewelry taken in the burglary is nearly \$25,000. The burglar(s) took a pillow sham from on LUTGEN'S bed - presumably, to load all of the nearby jewelry into. The value of the damage to her solid wood door and to other areas is nearly \$1,000. I routed LUTGEN'S property loss documents through our records unit. LUTGEN and I would correspond via email in the coming days. I shared with her what little I know about the APS.

I told LUTGEN with no solvability such as suspects, witnesses or evidence, the case would be PENDED. I made sure LUTGEN had my name and contact information. I encouraged her to call with any additional information and explained that the case would immediately be re-opened if solvability factors became known to department personnel.
