Revocation of Fire Certificate of Occupancy and Order to Vacate

Dear Property Representative:

Your building was inspected on March 16, 2012, for the renewal of the Certificate of Occupancy. Since you have failed to comply with the applicable requirements, it has become necessary to revoke the Certificate of Occupancy in accordance with Section 40.06 of the Saint Paul Legislative Code. A reinspection will be made on April 16, 2012 or the property vacated.

The Saint Paul Legislative Code further provides that no building shall be occupied without a Certificate of Occupancy. Failure to immediately complete the following deficiency list or the building vacated may result in a criminal citation.

DEFICIENCY LIST

- 1. Main floor SPLC 34.10 (4), 34.33 (3) Provide a bathroom floor impervious to water. After securing toilet to floor caulk the base.
- 2. Main floor SPLC 34.11, SBC 2902.1, SPLC 34.17, MPC 415.0220 Repair or replace and maintain the plumbing fixture to an operational condition.-Repair or replace and maintain an approved private toilet. Secure toilet to floor.
- 3. Main floor MN State Statute 299F.50 Immediately provide and maintain an approved Carbon Monoxide Alarm in a location within ten (10) feet of each sleeping area. Installation shall be in accordance with manufacturers instructions.
- 4. Remove all cans marked extremely flammable. MN Stat 299F.18 Immediately remove and discontinue excessive accumulation of combustible materials.-Remove from furnace room.

- 5. basement MSFC 605.6 Provide electrical cover plates to all outlets, switches and junction boxes where missing.
- 6. SPLC 34.11 (6), 34.34 (3) Provide service of heating facility by a licensed contractor which must include a carbon monoxide test. Submit a completed copy of the Saint Paul Fire Marshal's Existing Fuel Burning Equipment Safety Test Report to this office.
- 7. SPLC 39.02(c) Complete and sign the provided smoke detector affidavit and return it to this office.

You have the right to appeal these orders to the Legislative Hearing Officer.
