Cut and remove tall grass, weeds and rank plant growth.

If you do not correct the nuisance or file an appeal before February 03, 2012 , the City will correct the nuisance and charge all costs, including boarding costs, against the property as a special assessment to be collected in the same way as property taxes. <u>Charges:</u> If the City corrects the nuisance, the charges will include the cost of correction, inspection, travel time, equipment, etc. The rate will be approximately \$260.00 per hour plus expenses for abatement.

*WARNING Code inspection and enforcement trips cost the taxpayers money.
