Please take notice that this matter has been set on the Public Hearing Agenda for the City Council meeting has been scheduled for **Wednesday, June 20, 2012 at 5:30 p.m.**, in the City Council Chambers, Third Floor, Saint Paul City Hall and Ramsey County Courthouse.

Enclosed are copies of the resolution and supporting documents which will be presented to the City Council for their consideration. This is an uncontested matter concerning the fact that on March 27, 2012, you submitted your liquor liability insurance to the Department of Safety and Inspections with a lapse in coverage from August 29, 2011 through March 21, 2012. A lapse in liquor liability insurance is a violation of Minn. Stat. § 340A.409 and Saint Paul Legislative Code § 409.065. Therefore, per Saint Paul Legislative Code § 409.26 (b) 12, the licensing office will recommend a ten (10) suspension of your licenses.




