Please take notice that this matter has been set on the Public Hearing Agenda for the City Council meeting has been scheduled for **Wednesday, June 20, 2012 at 5:30 p.m.**, in the City Council Chambers, Third Floor, Saint Paul City Hall and Ramsey County Courthouse.

Enclosed are copies of the resolution and supporting documents which will be presented to the City Council for their consideration. This is an uncontested matter concerning the fact that on April 2, 2012, the Department of Safety and Inspections received a certificate of liquor liability insurance from you with a lapse in coverage from February 1, 2012 through April 1, 2012. A lapse in liquor liability insurance is a violation of Minn. Stat. § 340A.409 and Saint Paul Legislative Code § 409.065. Therefore, per Saint Paul Legislative Code § 409.26 (b) 12, the licensing office will recommend a ten (10) suspension of your licenses.
