# SUBGRANT AGREEMENT BETWEEN THE CITY OF SAINT PAUL AND RAMSEY COUNTY

This subgrant, and amendments and supplements thereto, made and entered into on the \_\_\_\_ day of June, 2012, is between the City of Saint Paul, a municipal corporation, 15 West Kellogg Boulevard, St. Paul, Minnesota 55102 (hereinafter the "City") and Ramsey County, 660 Government Center West, 50 W. Kellogg Boulevard, Saint Paul, Minnesota, 55102 (hereinafter "County")

WHEREAS, the City has received a grant award from the Minnesota Department of Commerce Division of Energy Resource for the installation of large and small-scale solar electric or thermal projects, including innovative energy storage technology, in a geographically concentrated area along and near the light rail corridor (hereinafter "Grant Award").

WHEREAS, the Grant permits and the City wishes to partner with the County to install a solar thermal system on the rooftop of the Ramsey County Law Enforcement Center and study how solar energy can be integrated into building's energy system.

NOW, THEREFORE, it is agreed:

### I. TERM OF AGREEMENT

This Agreement shall take effect and be in force from and after the date above, which shall be the date upon which this Subgrant Agreement has been fully executed by both parties, and shall remain in effect until the County has performed all of its obligations hereunder, unless earlier terminated as provided in this Agreement.

#### II. CONSIDERATION AND TERM OF PAYMENT

The City shall pay \$XXXX to install a solar thermal system on a Ramsey County facility as soon as practical upon execution of this Agreement, in return for which the County will assume ownership of the solar thermal system and a contractual obligation to own and maintain the system for a period covering the expected life of the system. Separate contract?

The City will pay for work performed upon receipt of itemized invoices for the services actually performed, and the City's authorized representative in Paragraph IV below accepts the services and approves the payments. Invoices shall be submitted in a timely manner on the schedule mutually agreed to by the parties.

#### III. CONDITIONS OF PAYMENT

All services provided by the County pursuant to this Agreement shall comply with all the applicable state and federal requirements for the Grant to the city and shall be in accord with all applicable federal, state, and local laws, ordinances, rules and regulations.

Failure to comply with the applicable grant requirements may result in termination of this Agreement and repayment of the grant sums in full or in part should the federal government require repayment from the City of the Grant funds due to such failure.

Special Terms and Conditions of the Grant are attached as Exhibit B and incorporated herein.
