As owner or person(s) responsible for: 995 CASE AVE you are hereby ordered to eliminate all nuisance conditions which are in violation of Chapter 45 of Saint Paul Legislative Code.
Remove improperly stored or <u>accumulated refuse</u> including: garbage, rubbish, discarded furniture appliances, vehicle parts, scrap wood and metal, recycling materials, household items, building materials or rubble, tires, <u>brush</u> , etc., from yard areas. DEBRIS BY GARAGE
Cut and remove tall grass, weeds and rank plant growth.
Remove and properly dispose of all animal feces from yard areas.
IMMEDIATELY secure all buildings which are open to unauthorized entry, including:

If you do not correct the nuisance or file an appeal before March 21, 2012 , the City will correct the nuisance and charge all costs, including boarding costs, against the property as a special assessment to be collected in the same way as property taxes. <u>Charges:</u> If the City corrects the nuisance, the charges will include the cost of correction, inspection, travel time, equipment, etc. The rate will be approximately \$260.00 per hour plus expenses for abatement.
You must maintain the premises in a clean condition and
provide proper and adequate refuse storage at all times

Appeals: You may appeal this order and obtain a hearing before the City Council by completing an appeal application with the City Clerk before the appeal deadline noted above or seven (7) days after the date mailed, whichever comes first.
