My name is Sam Dolce, and I am a resident of Ward 4 in Saint Paul. There is a new college housing ordinance that is up for vote on Tuesday, as I'm sure you are aware. If this passes, I assure you it will have a negative influence for the community surrounding Macalester College. I understand that noise complaints have become a more pressing problem, and St. Thomas is not alone to blame. That being said, as college students and members of the community, it is unethical as well as unintelligent to rob the community of our involvement and participation.

90 percent of students at Macalester College are involved in civic engagement every semester without there being a requirement to do so. This means that the vast majority of the students living off campus are directly involved in voluntary work to improve the community that is trying to disband them due to the crimes of a few (that have been adequately punished with the first fine being over 900 dollars for a reported house party).

Over 70 percent of students at Macalester receive financial aid, with the average sum awarded being 36,540 dollars. That means that the majority of kids attending the college cannot afford to attend the school. Living off campus is much less expensive than living on campus. For that reason the majority of seniors and juniors move off campus. I personally save thousands of dollars a year by living in a house on Ashland Avenue. If this option was not open to me, my ability to attend the school would be in question. If this ordinance passes, then the prices for student housing in the area would sky rocket.

I am from Buffalo, New York, nearly a thousand miles away. Macalester brought me a thousand miles and relocated my efforts to improve the world to this neighborhood. If the government of this city decides to take Macalester and turn it into a bubble instead of an integrated part of the community, its allure is greatly diminished. Students like myself might not be able to afford, and may not want to go to such an institution. The biggest difference between Macalester and other similar institutions is its placement in the middle of a sprawling metropolitan area. While giving tours of campus (my on campus job), one of the most frequently asked questions is "How involved and integrated Macalester students are in the neighborhood?" I am proud to tell multiple stories about my friends' experiences with civic engagement and doing community service.

The problems being faced by our community are not student ghettos, but instead a few college kids being rowdy. Parents do not want their children being woken up by rambunctious college students in the middle of the night. That makes sense. But how does this proposal adress that? It is a terrible idea to attack on a part of the community that may be the best set for success in the long run. My time in this city will influence my decision to stay here after graduation.

Why would you scare away the thousands of possible graduates of one of finest learning instituions in the country from moving into this neighborhood post graduation?

Lastly, this is an attempt to create legislation that would legally authorize an unethical attack on a minority within a greater community. Because we are from across the world it may be believed that we have little voice, due to the fact that a lot of students do not vote in local elections. I will remind you, Macalester students are not known for keeping their opinions quiet, and Macalester graduates in the area are well connected and influential.

I hope that my e-mail finds you well. As you can guess, I am writing to you today in opposition to the proposed change to the housing ordinance in the neighborhoods of Mac-Groveland and Merriam Park.

As a student at Macalester College, I chose to move off campus in order to gain independence and the experience living "alone" before I head out into the real world after graduation. I believe that these two years living in a more independent manner are critical to success after college, where my bills won't be paid by Macalester and my sidewalk won't shovel itself. I am now more financially literate, I know how to pay my bills on time, and I feel comfortable interacting with my landlord. As a result of living off campus, I have been able to grow as a person -- I believe that I am less isolated in the "Macalester bubble," I believe that I am more aware of the concerns of my neighbors, and I believe that I am more aware of the effects of my actions on others.

As I am sure you are aware, Macalester has little space for more student housing, especially the types of student housing which would encourage student independence and accountability. Furthermore, only 8% of Macalester students have cars at schools. I am one of the 92% who don't. Macalester is a demanding school, and I spent countless hours in the library -- often coming home at 12 am or 1 in the morning from a night of studying. The new ordinance would force me, and students like me, to live even further from campus, making the trek home not only lengthy and tiring, but flat out dangerous.

I realize that many of those in support of this new ordinance believe that it will serve to preserve the character and quality of the neighborhood. However, it is not the density of student housing that it at the root of their problem. It is the fact that parties go on too late, that students can be irresponsible and disrespectful when drunk, and that some people are just plain ignorant. Forcing students to move further from campus will not help this problem. I can see the line of thinking, however I believe that these issues are more effectively addressed by the Social Host Law, already in place. Hi Mr. Williams -

I will be a sophomore at Macalester in the fall, and while I can't attend the hearing because I'm home in Portland, Oregon for the summer, I would definitely be present if I were in town. As someone who is planning and relishing living off campus after my sophomore year, this ordinance affects me in a negative way. My peers who live offcampus are respectful and courteous people, and have only mentioned complimentary things about the neighborhood, their neighbors, or their landlords - nothing negative. In order to gain some understanding of the issue, I read through the entire "In Support" document, featuring letters and emails from neighborhood residents arguing that the rowdy behavior that accompanies students living off-campus had reached a point of oversaturating the neighborhood, the ordinance being the solution to the problem. I found it interesting that every complaint had to do with the University of St. Thomas, and not a single one mentioned Macalester. I think this is an important distinction. While St. Thomas may be growing, Macalester has stayed right around 1900-2000 students for the past four years, and my graduating class will be the smallest on campus in the fall - minus the incoming freshman class. So, by the time I reach my senior year, there will most likely be fewer Macalester students living off campus than there are today.

Secondly, I think the distinction between UST and Mac goes beyond enrollment. Macalester attracts a type of student that is very self-aware for his/her age, and who cares deeply about the impact they have on their surroundings. I know this is the typical catchphrase you might see on a Mac pamphlet, but after a year in the school, I can attest for myself that this is true. From a cultural standpoint, the behavior detailed in these letters would be appalling at Mac. We had an incident at our Winter Formal where several students were overly intoxicated and vandalized the building it was hosted in. As a result, several letters to the editor of the Mac Weekly, one by the Dean of Student Life but most by fellow students, detailing their shock and disappointment at how Mac students could behave in this way. While Mac students are obviously not immune to this behavior, I have never seen a fight, broken glass, or vandalism at an off-campus party, and when they are occasionally broken up by police, students leave quietly and respectfully. This is not a put-down of UST; it is a fine school, but this is one area where I think Macalester really excels and is well above average.

Finally, Mac's integration with the neighborhood is central to its character. When I applied to college, I looked at several other well-regarded liberal arts schools, almost identical to Mac on paper. However, I ultimately decided on Mac because of its location - I was impressed with the Twin Cities when I visited, and over the course of the past year, have grown to think of them as my true home. I look forward to moving off campus and integrating with the broader St. Paul community, and definitely envision myself living here after college. However, Mac is expensive, and I'm going into debt to attend. Living off campus is currently cheaper than living on campus, but this ordinance will jack up rent prices to the point that living on campus is potentially the cheaper option.
