As owner or person(s) responsible for: 1328 SEARLE ST you are hereby ordered to eliminate all nuisance conditions which are in violation of Chapter 45 of Saint Paul Legislative Code.
Remove improperly stored or accumulated refuse including: garbage, rubbish, discarded furniture appliances, vehicle parts, scrap wood and metal, recycling materials, household items, building materials or rubble, tires, brush, etc., from yard areas.
Cut and remove tall grass, weeds and rank plant growth.
IMMEDIATELY secure all buildings which are open to unauthorized entry, including: two
windows in front porch. Thank you.
Other:
If you do not correct the nuisance or file an appeal before July 05, 2012 , the City will correct the nuisance and charge all costs including boarding costs, against the property as a special assessment to be collected in the same way as property taxes. <u>Charges:</u> If the City corrects the nuisance, the charges will include the cost of correction, inspection, travel time, equipment, etc. The rate will be approximately \$260.00 per hour plus expenses for abatement.
