NOTICE OF INTENT TO SUSPEND LICENSE

Andrea K. Pesses Groveland Confections 290 – 5th Street East St. Paul, MN 55101

Retail Food Establishment – Farmer's Market license held by Andrea K. Pesses d/b/a Groveland Confections for the premises located at 290 – 5th Street East in Saint Paul License ID #20110000373

Dear Ms. Pesses:

The Department of Safety and Inspections (DSI) has recommended suspension of the Retail Food Establishment – Farmer's Market held by Andrea K. Pesses d/b/a Groveland Confections for the premises located at $290-5^{th}$ Street East in Saint Paul. The basis for the recommendation is as follows:

On June 5, 2012, you were sent a letter and <u>RENEWAL INVOICE</u> from the Department of Safety and Inspections (DSI) stating that your Retail Food Establishment – Farmer's Market license expired as of February 3, 2012. You currently owe \$244.00 in delinquent license and late fees. You are also required to complete and submit the enclosed <u>Certificate of Compliance Minnesota Workers' Compensation Law form.</u>

You were given until June 26, 2012, to pay the license and late fees. As of today's date, the fees have not been paid.

At this time, you have three options on how to proceed:

1. You can pay the delinquent license and late fees and submit the enclosed requested information. If this is your choice, you should send the payment and information directly to the Department of Safety and Inspections, at 375 Jackson Street, Ste. 220, St. Paul, Minnesota 55101-1806 no later than Monday, July 30, 2012. Information should be directed to the attention of Christine Rozek. A self-addressed envelope is enclosed for your convenience. Payment of the delinquent license and late fees and submission of the enclosed requested information will be considered to be a waiver of the hearing to which you are entitled.

- 2. If you wish to admit the facts but <u>contest</u> the penalty, you may have a public hearing before the Saint Paul City Council, you will need to send me a letter with a statement admitting the facts and requesting a public hearing. I will need to receive your letter by **Monday**, **July 30**, **2012**. The matter will then be scheduled before the City Council for a public hearing to determine whether to suspend your license. You will have an opportunity to appear before the Council and make a statement on your own behalf.
- 3. If you no longer wish to do business in the City of Saint Paul, you will need to send a written statement to that effect to the Department of Safety and Inspections, at 375 Jackson Street, Ste. 220, St. Paul, Minnesota 55101-1806 no later than **Monday**, **July 30**, **2012**. Information should be directed to the attention of Christine Rozek.

If you have not contacted me by Monday, July 30, 2012, I will assume that you do not contest the suspension of your license. In that case, the matter will be placed on the City Council Consent Agenda for approval of the recommended penalty.
