CORRECTION NOTICE

RE: **737 RIDGE ST** File #: **11-298582**

Dear Sir or Madam:

The City of Saint Paul, Department of Safety and Inspections has inspected the above referenced property on **November 08, 2011** and has determined that the following deficiencies exist in violation of the Saint Paul Legislative Code¹ (see footnote 1, below).

- 1. INTERIOR STORAGE: There is an excessive accumulation of storage in the garage constituting a fire hazard and endangering both occupants and responding emergency personnel. Remove storage from garage.
- 2. ROOF: The roof is deteriorated, defective, or in a state of disrepair. Repair or replace the roof covering to a sound, tight and water impervious condition. Permit may be required.
- 3. SIDING/TRIM/THRESHOLD/GUTTERS: The exterior walls of the house and/or garage are defective. Repair all holes, breaks, loose or rotting siding, to a professional state of maintenance, including front door threshold and wooden gutters.
- 4. The exterior walls and/or trim of the house and/or garage has defective, peeled, flaked, scaled or chalking paint or has unpainted wood surfaces. Scrape and repaint to effect a sound condition in a professional manner.

You are hereby notified to correct these deficiencies in accordance with the appropriate codes. The Enforcement Officer will reinspect these premises on or after

December 07, 2011 for item 1 **May 31, 2012** for items 2-5

by which date the violations noted must be corrected. **Failure to correct these deficiencies may result in the issuance of criminal charges**² and/or a civil lawsuit, and possible abatement/assessment by the City. All repairs and new installations must be made in accordance with the appropriate codes. Permits may be obtained by calling 651-266-8989.

You may file an appeal to this notice by contacting the City Clerk's Office at 651-266-8688. Any appeal must be made in writing within 10 days of this notice. (You must submit a copy of this Notice when you appeal, and pay a filing fee.)
