Failure to comply may result in a criminal citation or revocation of the Certificate of Occupancy. The Saint Paul Legislative Code requires that no building shall be occupied without a Certificate of Occupancy. The code also provides for the assessment of additional re-inspection fees.

#### **DEFICIENCY LIST**

- BEDROOM EGRESS WINDOWS OPENABLE DIMENSIONS MSFC1026.1 Provide and 1. maintain an approved escape window from each sleeping room. The minimum size must be 5 square feet of glazed area with a minimum of 24 inches of openable height and 20 inches of openable width. With a finished sill height not more than 48 inches. This work may require permit(s). Call DSI at (651) - 266-9090. Refer to the Escape Windows for Residential Occupancies handout for more information.-Openable dimensions are: Southwest bedroom -21 inches high by 32 inches wide. West bedroom -13 inches high by 32 inches wide. Northwest bedroom 13 inches high by 32 inches wide.
- EXTERIOR STEPS PROVIDE HANDRAILS SPLC 34.09 (2) 34.32 (2) Provide an approved 2. handrail. The top of the handrail must be between 34 and 38 inches above the treads and run the entire length of the stair.-Provide handrails for the front and side steps.
- OPEN JUNCTION BOXES PROVIDE COVER PLATES MSFC 605.6 Provide electrical cover plates to all outlets, switches and junction boxes where missing.-Provide cover plates for the open box near the washing machine and near the furnace.
