An inspection was made of your building on November 8, 2012 in response to a referral. You are hereby notified that the following deficiency list must be corrected immediately. A reinspection will be made on or after November 16, 2012.

Failure to comply may result in a criminal citation or revocation of the Certificate of Occupancy. The Saint Paul Legislative Code requires that no building shall be occupied without a Certificate of Occupancy. The code also provides for the assessment of additional reinspection fees.

DEFICIENCY LIST

- First floor SPLC 62.101 Use of this property does not conform to zoning ordinance. Immediately Discontinue unapproved use and contact DSI Zoning at (651) 266-8989 to convert to legal use. Immediately Discontinue any residential use on the first floor without approval.
- First floor SPLC 34.23, MSFC 110.1 The first floor is condemned as unsafe or dangerous. This occupancy must not be 2. used or occupied until inspected and approved.-Construction and electrical work in the building not done to code or under permit immediately discontinue work. Submit plans for all work and obtain permits and approval for work done.
- 3. First floor - SPLC 34.10 (2), 34.33 - Construction and electrical work in the building not done to code or under permit immediately discontinue work. Submit plans for all work and obtain permits and approval for work done. This repair will require a building permit, call DSI at (651) 266-9090.
