Total area minus area under radiator: 126 square feet

Area with ceiling seven feet or higher: 64.5

## **Bedroom 2**

Goal: 50% or more of ceiling seven feet or higher.



Total area minus area under radiator: 107.5 square feet Area with ceiling seven feet or higher: 57 square feet

Percent with ceiling seven feet or higher: 53%

Note: If the inspector's measurements and his assertion that only 44% not 50% of the area of the bedrooms stand seven feet high or more are somehow "more correct" than ours, we have a shortfall of 6%. Six percent of Bedroom 1 is 7.7 square feet; of Bedroom 2, 6.8 square feet, both slightly less if we disregard the area beneath the radiators. In this event, I request a variance for each bedroom, because the shortfall is trivial and the ceiling height at the lowest end of the room (above the radiators) is still a full six feet.

I suppose we could install bookshelves or extra closets on either or both sides of the radiators, reducing the total area and increasing the percent above seven feet to 50% or higher. But this seems unnecessary owing to the trivial shortfall.
