Mr. Robinson stated orders were issued on June 26, 2008 to remove tires, refuse under tarp, and household items that had been strewn throughout the yard with a compliance date of July 1. The property was re-inspected on July 8 and the work had not been done. A work order was sent to the Parks Department who did the work on July 15, 2008 for a total assessment of \$476.

Parke Schilling, property owner, appeared with Lynne Warneke. Mr. Schilling stated that his sister had recently passed away and he was responsible for disposing of her personal effects. He had organized a yard sale for the weekend of the 4th of July and what did not sell, he was going to take to the Salvation Army. He admitted that the tires were his; however, he maintained that he had health issues and with the heat, he could only do a little bit of work at a time. He also claimed that he was present when Parks came to do the clean up and they had smashed their truck into his fence. He believed the City should be responsible for the cost of the repair to his fence.

Ms. Moermond asked to see the video which showed 15 plus tires, loose and scattered debris, furniture, and an exercise bike that were removed, as well as many items that were not taken, such as rakes, tools and other furniture.

Ms. Moermond asked Mr. Schilling whether he had called the inspector and requested an extension of time to complete the work. Mr. Schilling responded that he had not.

Ms. Moermond stated that he had two and one-half weeks to clean up the property and had failed to call the inspector to request an extension of time. She stated that she would need to review the file and talk to Officer Koehnen; therefore her recommendation was forthcoming. She suggested Mr. Schilling file a claim with the City Clerk's Office for the cost of any damage that may have been done to the fence by the Parks crew. After the hearing, Ms. Moermond reviewed the file and recommended approving the assessment.
