The front door was clearly marked with a bright yellow sign " Vacant , No Trespassing " by Ramsey County . Both stated they had entered with 3 other parties only known as " Trap " , " C'Money " and " Lat " who stated they lived there so they went in with them . They said when the police arrived they got trapped in the building as the others fled .

It should be noted that besides the sign the residence is clearly vacant . There is no furniture or any other misc. items that would lead someone to believe it is lived in . The house is completely empty .
