PROPOSED DESCRIPTION FOR AIR RIGHTS VACATION

Said vacation is to project into and over the public right-of-way of Washington Street and West Fifth Street and is described as those parts of Washington Street and West Fifth Street (Formerly known as Peart Street) adjoining Block 12, RICE AND IRVINE'S ADDITION TO ST. PAUL, according to the recorded plat thereof, Ramsey County, Minnesota, described as beginning at the northeast corner of said Block 12; thence westerly, along the northerly line of said Block 12, a distance of 20.00 feet; thence northerly deflecting right 90 degrees 00 minutes 00 seconds a distance of 10.00 feet; thence easterly deflecting right 90 degrees 00 minutes 00 seconds a distance of 24.00 feet; thence southeasterly deflecting right 45 degrees 03 minutes 24 seconds a distance of 16.98 feet to a line 16.00 feet easterly of and parallel with the easterly line of said Block 12; thence southerly, along said parallel line, a distance of 100.00 feet; thence deflecting right 90 degrees 00 minutes 00 seconds a distance of 6.00 feet to a line 10.00 feet easterly of and parallel with said easterly line of Block 12; thence northerly, parallel with said easterly line of Block 12, a distance of 102.01 feet to the easterly extension of said northerly line of Block 12; thence westerly, a distance of 10.00 feet to the point of beginning.

Said vacation lies between the elevations of 108.33 feet and 144.00 feet per City of St. Paul Datum.

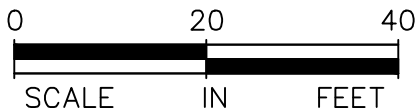
